

#### Section 4:

#### First Aid Measures

Eyes:

Immediately flush eyes with excess water for 15 minutes, lifting lower and upper eyelids occasionally.

Skin: Ingestion: Immediately flush skin with excess water for 15 minutes while removing contaminated clothing. Call Poison Control immediately. Do not induce vomiting. Rinse mouth with cold water. Give victim 1-2 cups of

water or milk to drink.

Inhalation:

Remove to fresh air. If not breathing, give artificial respiration.

#### **Fire Fighting Measures**

When heated to decomposition, emits acrid fumes.

Protective equipment and precautions for firefighters: Use foam or dry chemical to extinguish fire. Firefighters should wear full fire fighting turn-out gear and respiratory protection (SCBA). Cool container with water spray. Material is not sensitive to mechanical impact or static discharge.

#### Accidental Release Measures

# Handling and Storage

White

Handling: Use with adequate ventilation and do not breathe dust or vapor. Avoid contact with skin, eyes, or clothing. Wash hands thoroughly after handling.

Storage: Store in Corrosive Area [White Storage] with other corrosive items. Store in a cool, dry, well-ventilated, locked store room away from incompatible materials.

## **Exposure Controls / Personal Protection**

Use ventilation to keep airborne concentrations below exposure limits. Have approved eyewash facility, safety shower, and fire extinguishers readily available. Wear chemical splash goggles and chemical resistant clothing such as gloves and aprons. Wash hands thoroughly after handling material and before eating or drinking. Use NIOSH-approved respirator with an acid/organic cartridge. Exposure guidelines Zinc Chloride, fume: OSHA PEL: 1 mg/m³, ACGIH TLV: 1 mg/m³, STEL; 2 mg/m³.
